**Subject: Brief/Minutes of 16<sup>th</sup> OHM held on 26/8/2014.**

The representatives of the following MSO applicants and a new applicant participated in the Open House Meeting as detailed below:-

- (i) **M/s Saga Entertainment Pvt Ltd.:** S/Sh. S. Sarvanan and R. Sarvanan attended the meeting. The company was granted provisional registration in July, 2012 to operate in DAS notified area of Tamil Nadu, Andhra Pradesh, Karnataka, Kerala, Pudduchery and Andaman & Nicobar Island etc. The company did not operationalize its services in Phase I & II. Show Cause Notice was issued but no reply from the MSO was received. However, they claimed that they have sent reply to the SCN. They also mentioned that they have installed a Headend and seeded over 3000 STBs. Today, they pleaded that they want to operate in Tamil Nadu State only. On this, it was advised to them to give in writing.
- (ii) **M/s DDC CA TV Network:-** Sh. Ravi Gupta attended the meeting. He was requested to send one more set of the Form 6 so that the same can be sent to MHA for security clearance.
- (iii) **M/s Technobile System:-** Sh. Paritosh Shukla attended the meeting. It was told to him that their case with Board of Directors' details in new format have been sent to MHA for security clearance.
- (iv) **M/s Venkatasai Media Pvt Ltd.:-** Sh. P. Srinivas Rao attended the meeting. He was requested to send declaration in Form 2 in the Stamp Paper, not in plane paper, as was sent to the Ministry. He assured that he will furnish the same within a week's time.
- (v) **M/s Vinsat Digital Pvt Ltd.:-** Sh. Chandrashekhar attended the meeting. He has already been given permanent MSO registration on 26.05.2014 to operation in Vishakhapatnam. He wishes to extend his operation in Phase III & IV area of Andhra Pradesh. He was asked to submit fresh application.
- (vi) **M/s Raju Digital Cable Network.:-** Sh. Raj Kumar Rawat attended the meeting. He was informed that his application has been sent to MHA for security clearance. He was requested to provide e-mail address as well as the DAS notified area where he wish to operate since the same was not mentioned in the application.

- (vii) **M/s Subhodaya Digital Pvt Ltd.:-** Sh. G. Srinivas attended the meeting. The application has already been sent to MHA in April, 2014 for security clearance. He informed that there is change in the Registered Office of the company as well as Board of Directors. He submitted a copy of Company's Resolution to this effect. He also submitted Board of Directors' details in new format with the new address of the company which will be sent to MHA for security clearance.
- (viii) **M/s COSSCO Communications:-** Sh. Subrata Guharey attended the meeting. He is the new applicant. As stated by him, before coming to the meeting he had already submitted application in R&I Section. A copy of his application was examined and it was observed that Network Certificate as well as financial status of the company was not there with application. He was asked for furnish the same.
- (ix) **M/s Siti Maurya Cable Network:-** S/Sh. Rajnish Dixit and Madanjeet Kumar attended the meeting. It was informed to them that security clearance in respect of one of Key Executives of the company is still awaited from the MHA. On receipt of the same the case will be process further.
- (x) **M/s Den Discovery Digital Pvt Ltd.:-** Sh. Vibhav attended the meeting. Revised Board of Directors' details as provided by the company in the revised format has already been sent to MHA on 25.08.2014.
- (xi) **M/s Premium Multilink Cable Pvt Ltd.:-** Sh. Vibhav attended the meeting. It was informed to him that the case has already been sent to MHA for security clearance. The requisite security clearance is still awaited. A reminder has also been sent to MHA to expedite the security clearance.
