

Subject: Brief/Minutes of 3rd monthly Open House Meeting held on 22.06.2015 with MSOs - reg.

The 3rd Open House Meeting with MSOs representatives was held on 22.06.2015 (Monday) in the chamber of DS(DAS). Representatives of following MSO applicants attended the meeting as detailed below:-

- (i) **Siti Cable Network Ltd.:-** Sh. Vishwa Bandhu Sharma attended the meeting. It was told to him that the security clearance has been received and the file is under submission. Further, as authorized by various MSO applicants he was also apprised of the status of applications *viz* M/s Master Channel Community, M/s Siri Digital Network Pvt. Ltd., M/s Krishna Teja Digital Cable Network, M/s Siti Karnal Digital Media, M/s Siti Jind Digital Media, M/s Siti Bhatia Network, M/s Siti Global Pvt. Ltd. and M/s Siti Jai Maa Durgee. He stated that for these companies provisional registrations are required. It was informed to him that in this regard the MSO applicants shall have to make a request to the Ministry along with the requisite Affidavit available on the Ministry's website.
- (ii) **M/s Gentle Entertainment:-** Sh. Avinash pandey attended the meeting. It was informed to him that the security clearance from MHA is awaited. He was also informed that original network certificate has not been made available. The same may be sent urgently.
- (iii) **M/s GTPL Hathway:-** Sh. Abhishek Masan attended the meeting. It was told to him that the security clearance in respect of one of the Directors is still awaited. The case will be processed further on receipt of the same.
- (iv) **M/s Dehradun Digital:-** Sh. Yogesh Nautiyal attended the meeting. It was informed to him that the security clearance from MHA is awaited. He was also informed that original network certificate has not been made available. The same may be sent urgently.
- (v) **M/s Vivek Cable Services:-** Sh. Vivek Shet attended the meeting. It was informed to him that the security clearance from MHA is awaited.
- (vi) **M/s Cat Vision Ltd.:-** Sh. Neeraj Bhatnagar attended the meeting. He was informed that security clearance in respect of one of the Directors is still awaited from MHA. On receipt of the same the case will be processed.
- (vii) **M/s Signet Digital Pvt. Ltd.:-** Sh. Mahendra Jadhav attended the meeting. It was informed to him that the security clearance is awaited from MHA.

- (viii) **M/s R J Vaghela Digital Pvt. Ltd.:-** Sh. Paras Mehta attended the meeting. It was informed to him that the security clearance is awaited from MHA.
- (ix) **M/s D J World Vision:-** Sh. Raghuvirsinh Vaghela attended the meeting. It was informed to him that the security clearance is awaited from MHA.
