

Subject: Brief/Minutes of 41st OHM held on 07.04.2015 - reg.

The following MSOs representatives attended the meeting:-

- (i) **(a) M/s Infinite Television & Telecom Pvt. Ltd. & (b) M/s K Net Pvt. Ltd.:-** Sh. Vikram Sharma attended the meeting. It was informed to him that security clearances in both the cases are awaited from MHA. On receipt of the same the cases will be processed.
- (ii) **M/s GTPL Hathway:-** Sh. Shaji Mathew attended the meeting. It was informed to him that security clearance in respect of one Director of the Company is pending from MHA.
